

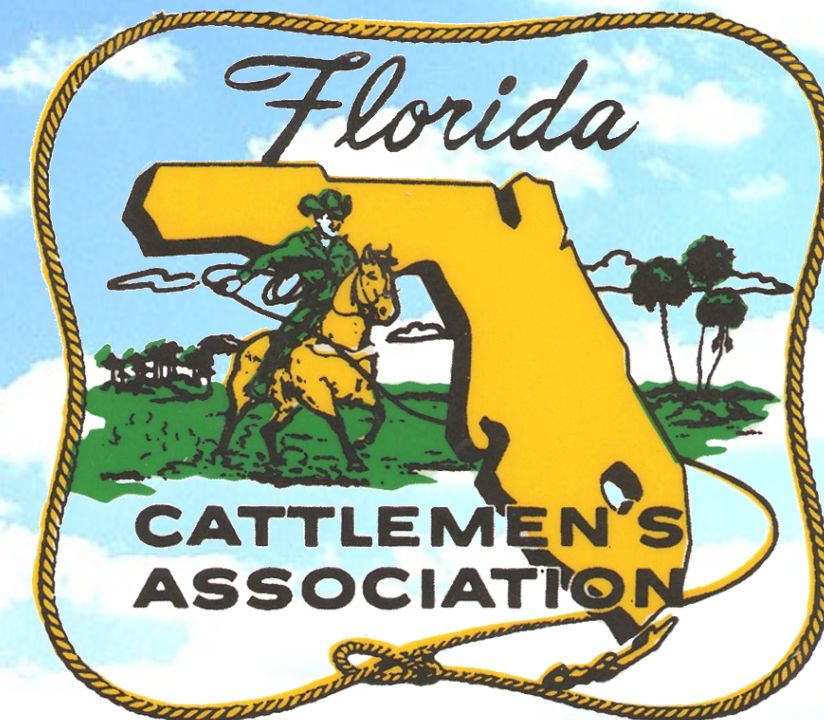

TRADE SHOW APPLICATION: Complete applications for trade show **must** be received at the FCA office by April 15, 2012, along with a check for booth space (s), and membership fee if you are not a current FCA member, made payable to: Florida Cattlemen's Association. There will be no convention registration requirement for exhibitors. Should any exhibitor wish to attend the meal functions during the FCA convention, a convention registration package must be purchased.

ASSIGNMENT OF BOOTH SPACE: Booth spaces will be assigned on a **FIRST COME, FIRST SERVE BASIS**. We have a limited number of booth spaces. Please send in booth agreements as soon as possible. All booth Agreements will be stamped with date received to insure fairness in first come, first served.

BOOTH INFORMATION: All spaces are carpeted and air conditioned. Some heavy equipment can be accommodated.
