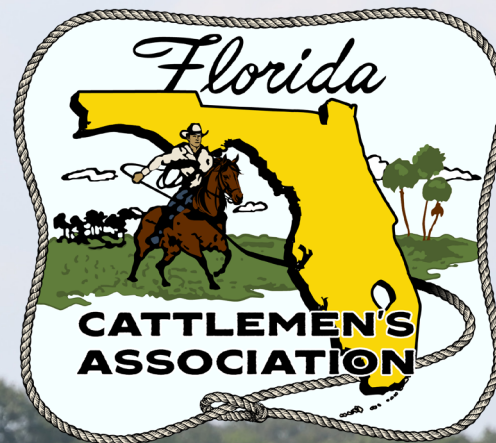

The Florida Cattlemen's Association (FCA) is a statewide, non-profit organization devoted entirely and exclusively to promoting and protecting the ability of cattlemen members to produce and market their products. This is done through legislative lobbying, product promotion and nutritional education. The FCA is an industry-wide, grassroots organization whose policies and programs are directed by input from local industry leaders and county affiliates.

## How is this goal met?

The FCA wears many hats, but below are a few key roles the Association plays so cattlemen can be successful:

**Legislative Voice:** FCA provides a strong voice for the cattle and beef industry, having representation in both Tallahassee and Washington, D.C.

**Reputation Management:** FCA works proactively to share the cattle industry's story with the general public to correct misinformation regarding animal health, beef nutrition and other industry misconceptions.

**Beef Cattle Research:** FCA partners with groups like IFAS at the University of Florida to conduct timely research, providing solutions to cattlemen for critical issues facing the industry.

**Environmental Preservation:** FCA works closely with government agencies like FDACS, DEP, and the WMDs to ensure their programs acknowledge the stewardship of working cattle lands. FCA closely monitors these programs so we can assist members with understanding exemptions, permitting and environmental compliance as it relates to their operations.
